#### 7. Rationale:

The pedagogical core of the Social Work in Gerontology program is based on two essential pillars. The first pillar is the use of evidence for both practice and policy. The second pillar is the primacy of an interdisciplinary approach to gerontological practice. As has been recognized since the 1940s, older adults and their situations are far too complex to leave their care to one profession. Gerontology has been committed to interdisciplinary team work long before it was in vogue and has purposefully designed curricula that requires students to work with cognate disciplines to learn about the roles of other disciplines in relation to their own, how to work effectively with them and how to be a respected member of the gerontological team.

The proposed gerontology program wishes to take advantage of the Collaborative Program on Aging and the Life Course where social workers will learn first hand what they cannot learn in a program exclusively made up of social workers. The Collaborative Program on Aging has strong representations from nursing, medicine, rehabilitation science, pharmacy, dentistry, psychology (to name a few) -- all crucial disciplines that social workers will have to work with when they enter practice in the field of gerontology. It makes sense that they should learn gerontology together at the outset so they are well-prepared for what lies ahead of them in actual practice.

Why make it required? -- because interdisciplinarity is a recognized and crucial aspect of the learning process in gerontology and because we have a natural laboratory where this learning is possible. We conceivably could teach a course on interdisciplinary approaches but the actual experience of taking interdisciplinary classes makes for an exciting and dynamic learning environment.

# MEMORANDUM OF AGREEMENT CONCERNING THE MSW IN SOCIAL WORK AND THE COLLABORATIVE PROGRAM IN AGING AND THE LIFE COURSE

## September, 2004

Memorandum of Agreement concerning the Collaborative Graduate Program in Aging and the Life Course offered at the Institute for Human Development, Life Course and Aging and the Faculty of Social Work, University of Toronto.

This agreement relates to the proposed agreement that Social Work students in the MSW Aging Concentration are required to take the Collaborative Graduate Program in Aging and the Life Course offered at the Institute for Human Development, Life Course and Aging. MSW students will take the master's level core course AGE2000H "Social Determinants of Health and Aging". The Institute and the Collaborative Program will ensure that a minimum of 10 seats per year will be made available to these students in the core course AGE2000H.

A review of this agreement will be made in 2 years time from the commencement of the concentration in September 2005 (September, 2007).

In return, the Faculty of Social Work agrees to continue to participate in the Collaborative Program in Aging and the Life Course and to support its activities by, mainly, but not restricted to, offering a faculty representative to work with the General Assembly on an annual basis and the Program Committee as required. The Faculty will continue to provide financial support for one teaching assistant for AGE2000H, the amount of the contribution prorated according to the proportion of social work students in the core course AGE2000H.
