RE: Representation and Fees of Part Time undergraduate students at UTM.

Dear Mr. Delaney,

I am writing to you to communicate the results of the move by the University of Toronto at Mississauga Students Union and the Erindale Part Time Undergraduate Students Council to realign all E.P.U.S, A.P.U.S and U.T.M.S.U services and representation into a single, restructured UTMSU for a single UTMSU fee per session.

On February 6th and 7th, 2008 the University of Toronto Mississauga Students' Union (UTMSU) on behalf of the Erindale Part-time Undergraduate Students (EPUS) held a referendum on the representation of part time undergraduate students. The referendum was conducted under the guidelines of both organizations and no infractions were found. The referendum passed by a 95% majority in favor of eliminating EPUS and APUS as representative bodies on the UTM Campus with regards to collection of fees.

The referendum also resulted in creating new fees for UTMSU that would replace the fees eliminated through the referendum. Please refer to the Fee increase request by UTMSU for a full breakdown of all the fees.

After seeking the appropriate approvals from the decision making bodies of the Erindale Part-Time Undergraduate Students and the University of Toronto Mississauga Students' Union, we would like to request on behalf of the Erindale Part-time Undergraduate Students (EPUS) and the University of Toronto Mississauga Students' Union (UTMSU) the following realignment of fees:

- 1) that the EPUS fee be reduced to zero;
- 2) that the APUS fee for UTM students be reduced to zero;
- 3) that the UTMSU fees be adjusted according to the referendum question;

Including:

- a) Canadian Federation of Students (CFS) and Canadian Federation of Students Ontario (CFS-Ontario) and their permitted cost of living increases
- b) Ontario Public Research Group (refundable)

- c) Accident & Prescription Drug Insurance Plan (refundable; increases up to 10% permitted without referendum approved spring 1994)
- d) Provincial Sales Tax on Accident & Prescription Drug Insurance Plan (refundable)
- e) Dental Plan (refundable; increases up to 10% permitted without referendum approved spring of 2005)
- f) Provincial Sales Tax on Dental Plan (refundable)
- g) Student Centre Levy (reduced to \$3.75 per session beginning in Fall 2009)
- 4) that EPUS be de-recognized as a student society of the University of Toronto;
- 5) that APUS be de-recognized as the "representative student committee" for UTM part-time students; and
- 6) that UTMSU be recognized as the "representative student committee" for UTM part-time students.
