I am writing to invite eligible members of the College of Electors who are interested in serving on the Executive Committee in 2009-10 to submit a nomination form. After the April 7th deadline, the Nominating Committee will meet to consider the nominations received and to prepare a slate for the Executive Committee. The College will elect the Vice-Chair and three additional members of the Executive at its first meeting in the Fall, 2009.

In developing its recommendations, the Nominating Committee will seek to achieve, to the extent possible, a mixture of members representative of the various divisions and colleges, the three campuses, and experience on both the College and on the Executive Committee.

The responsibilities of the Executive Committee are to advise the Chair on electoral procedures and to undertake duties as assigned by the College.

Members of the Executive Committee will be elected for a one-year term and are eligible for re-election for a second one-year term. Members in their first year on the College are ineligible to serve. The members of the Executive Committee of the College for 2008-09 are Mr. Colin Swift, Vice-Chair, Ms Ann Clarke, Mr. Lennox Phillips, and Mr. Bill Wrigley. Only Mr. Wrigley is eligible for re-election to the Executive in 2009-10, as the other members will have served two years on the Committee as of June 30, 2009.

Members are welcome to nominate other members of the College and/or to nominate themselves. A list of members eligible to serve on the Executive Committee in 2009-10 and a nomination form are attached for your convenience.
