ITEM IDENTIFICATION:

Compulsory Non-Academic Incidental Fees – Student Society Fees: Student Society Proposals for Fee Increases

JURISDICTIONAL INFORMATION:

The terms of reference of the University Affairs Board provide that the Board approves the establishment of and changes to compulsory non-academic incidental fees including those collected on behalf of student societies.

The administrative procedures are outlined in the *Policy on Compulsory Non-Academic Incidental Fees* and the *Handbook for Student Societies* (published by the Office of the Vice-Provost, Students). Pursuant to the *Policy*, requests for increases to fees must be supported by due constitutional and fair processes within student societies.

Requests for increases are brought forward to the Board by the administration on the assurances of the student societies that due constitutional procedures have been followed.

Increases which are greater than the cost of living must be supported by a positive result in a recent referendum. Requests for increases which are less than or equal to the cost of living must be supported by a previous referendum approving annual increases by an established inflation factor. When such a provision is approved by referendum, annual increases, no greater than the Ontario Consumer Price Index of the previous December (or no greater than a specific inflation factor approved by referendum), may be requested upon approval of the board or council of the organization.

PREVIOUS ACTION TAKEN:

Requests for changes to existing fees and/or the establishment of new fees are brought forward to the Board on one or more occasions each year. This is the first set of requests on behalf of student societies brought forward this year.

The requests have been reviewed by the Office of the Vice-Provost, Students and are recommended for approval.

HIGHLIGHTS:

The following student societies have requested changes to fees charged on their behalf by the University:

U of T Community Radio (CIUT-FM) Association of Part-time Undergraduate Students (APUS) Engineering Society (EngSoc) Faculty of Information Studies Student Council (FISSC) Graduate Students' Union (GSU) Erindale College Student Union [operating as the U of T Mississauga Students' Union (UTMSU)] Scarborough Campus Community Radio (SCCR) Scarborough Campus Students' Union (SCSU) Students' Administrative Council [operating as the U of T Students' Union (UTSU)] University College Literary & Athletic Society (UC Lit.) Undergraduate Pharmacy Society (UPS) Varsity Publications Inc. (*The Varsity*)

Additional information is provided in the attached memorandum from Jim Delaney, Director, Office of the Vice-Provost, Students.

FINANCIAL AND/OR PLANNING IMPLICATIONS:

There are no significant implications for the University's operating budget.

RECOMMENDATION:

It is recommended that the University Affairs Board approve the following:

THAT beginning in the fall 2009 session, the St. George **U of T Community Radio** (CIUT-FM – St. George) fee be increased by \$1.25 per session in the society's portion of the fee. If approved, the total CIUT fee charged will be increased to \$3.75 per session, charged to all full-time undergraduate students on the St. George campus.

THAT beginning in the fall 2009 session, the **Association of Part-time Undergraduate Students** (APUS) fee be increased \$0.05 per session in the Canadian Federation of

Students (CFS) – CFS-Ontario portion of the fee. If approved, the total APUS fee charged will be increased to \$77.54 per session, charged to all part-time undergraduate students.

THAT beginning in the fall 2009 session, the **Engineering Society** fee be increased as follows: (a) continuation and an increase of \$25.00 per session in Special Projects Levy portion of the fee; (b) continuation and an increase of \$0.25 per session for the Formula SAE portion of the fee; (c) continuation of the Engineering Career Centre portion of the fee; (d) continuation of the Human Powered Vehicle Design portion of the fee; (e) continuation of the Engineers Without Borders portion of the fee; (f) an increase of \$0.33 per session in the Society portion of the fee for all full-time Faculty of Applied Science and Engineering students. If approved, the total Engineering Society fee will be increased to \$123.18 per session, charged to all full-time Faculty of Applied Science and Engineering students. The fee for part-time students would remain unchanged at \$20.99.

Note: Beginning in fall 2009, the Engineering Society has elected not to renew the collection of the designated portion of the fee for *the Atrium Renovation Project*.

THAT, beginning in the fall of 2009, the **Graduate Students' Union** (GSU) fee be increased as follows: (a) an increase of \$0.17 per session for full-time students (\$0.09 per session for part-time students) in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee; (b) an increase of \$2.47 per session (full-time students only) (including administration fee and provincial sales tax) in the Supplementary Health Coverage portion of the fee; and (c) a increase of \$4.18 per session full-time and part-time students (including administration fee and provincial sales tax) in the Dental Plan portion of the fee. If approved, the total GSU fee will be increased to \$209.72 per session for full-time students (\$80.89 per session for part-time students), charged to all graduate students.

Note: Beginning in fall 2009, the GSU has requested to terminate the collection of the designated portion of the fee for *The Peer Review*. Since this fee was not collected in the 2008-09 academic year the fees reported above will not be affected.

THAT beginning in the fall 2009 session, the **Erindale College Student Union** (operating as the University of Toronto Mississauga Students' Union; UTMSU) fee be increased as follows: (a) an increase of \$0.19 per session in the society portion of the fee; (b) an increase of \$3.60 per session for the UPass portion of the fee; (c) an increase of \$0.01 per session for the Academic Societies portion of the fee; (d) the establishment of a new designated portion of the fee for a Food Bank of \$0.50 per session; and (e) the establishment of a new designated portion of the fee for the WUSC of \$1.00 per session. If approved, the total UTMSU fee will be increased to \$80.94 per session, charged to all full-time undergraduate University of Toronto at Mississauga students.

THAT beginning in the fall 2009 session, the **Scarborough Campus Community Radio** (SCCR) fee be increased by \$0.05 in the society portion of the fee. If approved, the total

SCCR fee will be increased to \$3.55 per session, charged to all full-time University of Toronto at Scarborough students.

THAT beginning in the fall 2009 session, the **Scarborough Campus Students' Union** (SCSU) fee be increased as follows: (a) an increase of \$0.35 per session for full-time students (\$0.02 for part-time students) in the society portion of the fee; (b) an increase of \$0.10 per session (full-time students only) in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee; (c) an increase of \$0.51 per session for full-time students (\$0.15 for part-time students) in the Student Centre portion of the fee; (d) an increase of \$3.08 per session (including administration fee and provincial sales tax) in the Accident & Prescription Drug Plan portion of fee; and (e) an increase of \$3.09 per session (including administration fee and provincial sales tax). If approved, the total SCSU fee will be increased to \$165.56 per session for full-time students (\$11.98 for part-time students), charged to all undergraduate University of Toronto Scarborough students.

THAT beginning in the fall 2009 session, the **Students' Administrative Council** (operating as the University of Toronto Students' Union; UTSU) fees be increased as follows: (a) an increase of \$0.24 per session in the society portion of the fee; (b) an increase of \$0.10 per session in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee; (c) increase of \$0.01 per session in the Student Refugee Program portion of the fee; (d) an increase of \$4.41 per session (including administration fee and provincial sales tax) in the Accident & Prescription Drug Plan portion of fee; and (e) an increase of \$4.67 per session for the Dental Plan portion (including administration fee and provincial sales tax); and (f) for full-time undergraduates on the St. George Campus only, an increase of the fee for the Student Common Project of \$0.08 per session. If approved, the total UTSU-St. George fee will increase to \$147.75 for all full-time undergraduate students on the St. George Campus; and the total UTSU-UTM fee will increase to \$140.42, charged to all full-time undergraduate students on the U of T at Mississauga campus.

THAT beginning in the fall 2009 session, the **University College Literary & Athletics Society** (UC Lit) fee be increased as follows (a) an increase of \$0.15 per session for fulltime students (\$0.05 for part-time students) in the society portion of the fee. If approved, the total UC Lit fee will be increased to \$18.10 per session for full-time students (\$9.00 for part-time students), charged to all University College students.

THAT beginning in the fall 2009 session, the **Undergraduate Pharmacy Society (UPS)** fee be increased as follows: (a) an increase of \$2.62 per session in the society portion of the fee; (b) an increase of \$2.00 per session for the Canadian Association of Pharmacy Students and Interns portion of the fee; and (c) an increase of \$1.00 per session for the Graduation Events portion of the fee. If approved, the total UPS fee will be increased to \$36.00 per session, charged to all full-time University of Toronto at Pharmacy students.

THAT beginning in the fall 2009 session, **The Varsity** fee be increased \$0.02 per session in the society portion of the fee. If approved, the total Varsity fee will be increased to \$1.27 per session, charged to all full-time University of Toronto students.

Subject:	Student Society Proposals for Fee Increases

Requests from a number of student societies for the fee changes listed below have been received by the Office of the Vice-Provost, Students. The applications have been reviewed and are recommended for approval.

Requests for fee increases from student societies must meet a number of requirements. Section 2 of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the University's general expectations:

Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization.

Where the amount of an increase in the fee charged is not greater than the year-overyear change in consumer prices for Ontario as measured by Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.

The procedures for handling fee change requests (from the *Handbook for Student Societies* published by this office) also provide that requests for a fee increase must be supplied with the following:

Evidence that the request to change the existing fee (or to institute a new charge) has been authorized by due constitutional process of the organization. This evidence should include a copy of or specific reference to the section of the society's constitution which relates to the mechanism for fee changes, minutes of the meeting at which the resolution to request the change was passed, details and results of any referenda related to the subject which may have been held within the division, and publicity given the matter to ensure that those who may be affected by the change are aware of the proposal, including size and purpose of the increase, and have had the opportunity to make their views known.

Normally, the administration intersects with these processes at two points. Initially, we ask student societies to seek advice from this office on the wording of referendum questions (with respect to clarity and technical language). The second point occurs after the referendum when the student society makes the formal request for a fee increase. The recommendation for approval is derived from the assessment of whether or not the society has met the requirements established in the *Policy* and the relevant procedures.

Occasionally, the Office is asked to look into complaints about referendum procedures and compliance with relevant portions of the society's constitution and/or by-laws. The results of these investigations play a significant role in the assessment of the request and the recommendation for approval.

The assessment of requests for fee increases is normally based upon the following expectations:

- 1) The student society must make the request in a manner consistent with the *Policy for Compulsory Non-Academic Incidental Fees* and the University's procedures for increases to student society fees;
- 2) There must be a positive result in a referendum for a fee increase (special conditions established by the society, such as quorum, must also be met);
- 3) The referendum question itself should be clear and provide enough information to students in order to gain a full understanding of the implications of the question and proposed fee for them;
- 4) The referendum must be held in a fair manner, advertised and promoted in a reasonable manner, and the members of each organization should be given a reasonable opportunity to vote; and
- 5) Each organization must comply with the provisions of its own by-laws, rules of procedure, and specific policies and procedures approved by the society's board or council.

Societies which have previously received approval (by referendum) from their members for an annual cost of living increase in the society's portion of the fee may request increases, upon approval by the society's board or council, of up to the previous Ontario December to December cost of living increase (consumer price index) calculated by Statistics Canada. The December 2008 consumer price index for Ontario was 1.5%.

The Students' Administrative Council (SAC)¹, the Graduate Students' Union (GSU), the

Association of Part-time Undergraduate Students (APUS), and the Scarborough Campus Students' Union (SCSU) may request increases in the designated portions of their fees for health and dental plans at a rate established by approval of a previous referendum. SAC, APUS and SCSU may request increases in their health plan fees of up to 10%. The GSU may request increases in the health plan fee of an amount less than or equal to a health industry index.

It is important to note that when dealing with a student society request for a fee change, it is the society's own constitution, by-laws or established policies that set the standards for acceptable results in referenda. In some cases, society constitutions establish a minimum voter turnout in order to consider a referendum result to be valid. The University has not established additional criteria with respect to valid referendum voter turnout.

U of T Community Radio (CIUT-FM)

Background

The CIUT-FM fee has been \$2.50 per session for all full-time University of Toronto undergraduate students at St. George campus since fall 2003.²

Requests

1) An increase to the Society portion of the fee beginning in the 2009-10 fall/winter academic period.

A referendum was held on April 7 and 8, 2009 (in addition to an advance voting opportunity on April 3, 2009) in which full-time undergraduate students on the St. George campus were asked to support the increase. The wording of the question is as follows:

Preamble:

University of Toronto Community Radio (CIUT 89.5 FM) is seeking consent from its students members for an increase to the Radio fee paid by Full-Time undergraduate students enrolled at St. George.

The existed fee, established in 1986 at \$2.50 per academic session, has not changed in 23 years! We are moving to Hart House in the summer of 2009.

We are seeking an increase of \$1.25 per academic session to establish an accessible presence in Hart House for students, and further our outreach to students and their continued

participation in our programming.

If the increase is approved, the total Radio fee would be \$3.75 per academic session beginning the fall of 2009.

Question

Recommendation:

THAT beginning in the fall 2009 session, the St. George U of T Community Radio (CIUT-FM – St. George) fee be increased by \$1.25 per session in the society's portion of the fee. If approved, the total CIUT fee charged will be increased to \$3.75 per session, charged to all full-time undergraduate students on the St. George campus.

Association of Part-time Undergraduate Students (APUS)

Background

In fall/winter 2008-09, the APUS fee charged to students was \$77.49 per session for parttime undergraduate students on all campuses. The fee includes \$3.38 per session for membership in the Canadian Federation of Students (CFS) and CFS-Ontario (CFS-O).

Pursuant to approval by previous referendum, requests for cost of living increases in the CFS/CFS-O portion of the fee are permitted upon approval of a resolution by the Assembly of Representatives of the society.

Requests

1) A cost of living increase in the CFS/CFS-O portion of the fee.

At its meeting held on March 31, 2009, the APUS Assembly of Class Representatives approved a resolution to request a cost of living increase to the CFS/CFS-O portion of the APUS fee.

Summary of Changes:

Recommendation:

THAT beginning in the fall 2009 session, the **Association of Part-time Undergraduate Students** (APUS) fee be increased \$0.05 per session in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee. If approved, the total APUS fee charged will be increased to \$77.54 per session, charged to all part-time undergraduate students.

Engineering Society

Background

The Engineering Society fee has been \$110.10 (\$20.99 per session for part-time students and Professional Experience Year (PEY) students) per session for full-time Faculty of Applied Science & Engineering students since fall 2007. The fee includes \$50.00 per session designated for a Special Projects Levy, \$12.50 for the Engineering Career Centre, \$2.00 for a Formula SAE Racing Team, \$1.25 for Human Powered Vehicle Design, \$1.25 for Engineering Without Borders, \$12.50 for an Atrium Renovation Project, and \$21.72 for the society for full-time students. The mandates to continue to charge the Engineering Career Centre, Formula SAE Racing Team, Human Powered Vehicle Design, Engineering Without Borders, and Atrium Renovation Project portions of the fee end this year. The mandate to continue to charge the Special Projects Levy ends in 2010.

Requests

1) An increase to, and the continuation of, the **Special Projects Levy** through the 2010-11 fall/winter academic period..

A referendum was held March 16 to 20, 2009, in which Applied Science & Engineering students were asked to support the increase. The wording of the question is as follows:

Preamble:

The Temporary Special Levy has remained constant at \$100 per year since the Levy's creation in 1983, and the cost of goods and services has almost doubled since then. The point of the fund is to purchase equipment every year that will directly enhance engineering undergraduate education, and the fee should be raised with inflation in order to continue to make a meaningful impact. The fund is matched by the faculty, such that 50 cents is added to every dollar raised from this levy.

Last year the fund was used to purchase oscilloscopes, Solid Works, Autocad, Matlab, Ansys, COMSOL, HSC and other software licensing, ECF's application servers, survey equipment, printers, function generators, machine shops, autoclaves, NMR spectrometers, microscopes, over 50 computers and many more items that increase our caliber of education here at the University of Toronto. These items are requested and approved by undergraduate students for their own use. This levy is important to continue purchasing new high-quality equipment that is necessary to be competitive as an engineering graduate.

On behalf of all full-time students registered in the Faculty of Applied Science and Engineering, the University of Toronto Engineering Society proposes an increase to the temporary Special Levy be levied upon full-time undergraduate students registered in the Faculty of Applied Science, subject to the following six provisions:

Provision 1: The amount of the temporary special levy be raised to \$75.00 per session (\$150.00 per fall/winter academic period). The levy will be charged to all full-time undergraduate Applied Science and Engineering students beginning in the fall 2009 session through the 2009-2010 and 2010-2011 academic years. The current levy of \$50.00 per session (\$100.00 per fall/winter academic period) shall be removed. Subsequent referendum approval will be required to continue the fee after the winter 2011 session.

Provision 2: The special levy shall be reviewed by the Engineering Society Council in the spring of 2010 and again in the spring of 2011. Review shall consist of a presentation to the Engineering Society Council of the expenditures which have occurred in the academic year.

Provision 3: Each department shall, with advice from their students, request expenditures from the Special Levy fund through the Engineering Society. Authorization for expenditure shall be made by a special committee of the Engineering Society with advice from the Dean of the Faculty of Applied Science and Engineering and Departmental Club Chairs. The committee shall include at least the President and the VP Finance.

Provision 4: The temporary special levy shall be used to purchase equipment which will enhance the quality of undergraduate education in the Faculty of Applied Science and Engineering.

Provision 5: The temporary special levy shall be collected by the University of Toronto with all regular fees for the 2009-2010 and 2010-2011 school years, and shall be passed to the Engineering Society in a separate bank account.

Provision 6: The nature and implementation of this agreement is absolutely contingent upon all of the preceding provisions.

In the course of considering this request for a fee increase, the Office of the Vice-Provost, Students did not receive complaints concerning the referendum or the request for an increase.

2) The continuation of the **Engineering Career Centre** portion of the fee through the 2010-11 fall/winter academic period.

A referendum was held March 16 to 20, 2009, in which Applied Science & Engineering students were asked to support the continuation of the fee for the next two years. The wording of the question is as follows:

Preamble:

In 2006 the Engineering Career Office merged with the Professional Experience Year (PEY) program to become the Engineering Career Centre (ECC). This evolution has allowed the ECC to increase the career supports and resources available to undergraduate engineering students, as well as offer additional flexibility to meet the vast demands of employers and their respective industries. This strength in unity has allowed the ECC to continue to incorporate valuable student development components into our services and programs.

On-campus recruitment activities include information sessions, all-day Career Booths in the SF Atrium and Bahen Atrium, and the annual Career Information Days in September of each year. Furthermore, the ECC acts in an advisory role to the different disciplines in their external outreach program, sharing the ECC database for these functions.

With both employer liaison staff as well as counsellors dedicated solely to student development via one-on-one, small group and workshops, the ECC has been able to provide alternatives to the PEY program in the form of ESIP (the Engineering Summer Internship Program), now in its fourth year, and the IOP (Infrastructure Opportunities Program), a 3summer rotational program for Civil Engineering students to gain 12 months' work experience in three different fields prior to graduation..

Our goal in developing these programs is to allow all Engineering students to have the opportunity to participate in a formalized development process with the goal of obtaining an exposure or experience component to add to their undergraduate education.

It will be our mission to continue to work and achieve further success in 2009-2010. We hope to continue the growth and further the development of our services with the renewal of the Career Centre levy for this term, such that the levy will no longer be required and the ECC can exist as a self-sustainable office.

The University of Toronto Engineering Society is seeking a renewal of the Engineering Career Office fee. The proposed fee is \$12.50 per session (\$25.00 per fall/winter academic year) for each full-time engineering undergraduate student for a period of 2 years beginning in the fall of the 2009-2010 academic year.

3) An increase to, and the continuation of, the **Formula SAE Levy** of the fee through the 2010-11 fall/winter academic period.

A referendum was held March 16 to 20, 2009, in which Applied Science & Engineering students were asked to support the increases and the continuation of the fee for this upcoming year. The wording of the question is as follows:

Preamble

The University of Toronto Formula SAE Racing Team was founded in 1997 by a small group of undergraduate engineering students. Today, it has grown to become an award winning design team comprising of undergraduate students from various Engineering disciplines. The team's mandate is to design, build and race an open-wheel, opencockpit high performance vehicle to compete in the Formula SAE/Formula Student Collegiate Design Competition.

In its short history the UofT team has won 3 European Championships, and currently ranks 4th among the 500 teams worldwide. We are one of the most successful and celebrated Formula Racing teams in the 26 year history of the series, and our success continues to represent the quality that employers associate with engineering students from UofT. On campus, the team is a hub of academic activity that provides all engineering students with workshops, guest lectures and team projects to develop skills that complement their studies. Every September, we organize and host the largest student run competition in the world, the UofT Shootout at Mosport International Raceway. Each year our team also actively promotes the University of Toronto and Engineering Faculties at on campus events as well as at dozens of major public events such as the Canadian International Autoshow.

Our past and present success has been made possible through the funding from our Engineering Society Levy and from you, the students. As we look forward towards the future, we hope that you will continue to support our team through the renewal and increase of the Formula SAE Levy; a \$4.50 fee per academic term (\$2.25 per fall/winter semester) for all full-time engineering undergraduate students. The money raised from this levy is crucial for our team to remain competitive in this ever growing series and will be used for the purchasing of parts for our vehicle, and to fund the transportation of our vehicle to competitions.

4) The continuation of the **Human Power Vehicle Design Team** fee through the 2010-11 fall/winter academic period.

A referendum was held March 16 to 20, 2009, in which Applied Science & Engineering students were asked to support the continuation of the fee for the next two years. The wording of the question is as follows:

Preamble

The University of Toronto Human Powered Vehicle Design Team (HPVDT) was established in 2006, and has since had great success due in large part to the support of you, undergraduate engineering students. The HPVDT currently has two technical projects; the first is a streamlined recumbent bicycle capable of speeds as high as 100 Km/h, which will compete in the ASME HPV Challenge in Philadelphia in April 2009. The second project is a human-powered ornithopter (HPO), a flapping wing aircraft. The HPO will push the limits of lightweight construction and efficient flight, and has already seen two years of design and prototype fabrication. A successful human-powered ornithopter will be the first successful piloted ornithopter in the world and the first successful human-powered aircraft in Canada.

The objective of HPaVDT is to promote hands-on and practical learning as a supplement to the theoretical teachings of the classroom. This experience provides unique preparation for a career as an engineer through emphasis on elegant and sustainable design. Team members utilize advanced optimization and design techniques including aerodynamic (CFD) and structural (FEM) analysis. Design meets implementation through construction using advanced composites and other revolutionary materials.

Both projects will continue to highlight the role of the Engineering Faculty as an innovator and environmental leader. The HPVDT has become an active member of the university community, hosting seminars on ornithopter flight and participating in the Sustainable Energy Fair. Further, we hope to encourage the use of alternative energies in transportation, while promoting self-improvement and environmental stewardship. Human power in particular remains an untapped yet viable means of long-distance transportation.

The HPVDT Levy is designed to make up 15% of the team's budget. This funding will be vital to the team and used to purchase equipment, software, and construction materials. The team is committed to actively pursuing outside sponsorship and donations, and has seen great success so far. We kindly ask for your support for the renewal of the Human Powered Vehicle Design Team Levy, a \$2.50 fee per academic term (\$1.25 per semester) for all full-time engineering undergraduate students.

Engineers Without Borders - University of Toronto Chapter (EWB-UT) is a Canadian international development organization dedicated to providing engineering students the knowledge, skills, and attitudes they need to be effective agents of change in human development.

EWB-UT and its members have taken tremendous leaps in leadership skills, knowledge of international development, and activity and presence on campus over the last two years. To support the ambitious line of events, projects, and overseas placements offered to engineering students, EWB-UT has been reliant on student levy funding – amounting to \$1.25 per engineering student per term – since 2007. The organization is kindly seeking to renew this commitment based on the excellent progress made by EWB-UT in its drive to integrate social responsibility and global-minded thinking into all aspects of campus life; additionally, its initiatives present engineering students with amazing opportunities to develop their skills as problem-solvers, leaders, socially conscious global citizens, and ultimately, as engineers.

Every year, EWB-UT sends two University of Toronto students on 4-month summer volunteer placements in sub-Saharan Africa where they work with a local organization to improve the living conditions for those living in extreme poverty. Here in Canada, EWB-UT holds bi-weekly workshops that inform students on the complexities of global poverty issues through case studies, and develop their ability to be leaders by enhancing their skills in presentation and critical analysis. EWB-UT's School Outreach Program reaches more than 1500 students annually, raising the topics of engineering, appropriate technology, and development into elementary and high school classrooms in hopes of sparking the fire of social responsibility and awareness in Canada's youth.

Additionally, the public outreach events EWB hosts promote Canadian public awareness of the causes and complexities of poverty, allowing thousands of Canadians the opportunity to positively impact the lives of people living in the world's poorest communities. Through EWB-UT's events and projects both at U of T and outside of it, engineering students are becoming global citizens and future leaders, as well as developing the invaluable skill of analyzing complex systems and problems, and spotting key leverage points that would affect change. Nothing speaks to this better than EWBUT's curriculum enhancement program that aims to integrate social development and problem-focused thinking directly into engineering courses. This year curriculum enhancement has been extremely active in reaching nearly one-third of all first-year engineering students who are taking APS series courses. This initiative's success has empowered members to propose more ambitious and impactful projects in the upcoming years.

EWB-UT strives to create an environment where engineering students can drive their own learning in becoming highly effective, socially responsible leaders. It envisions U of T as a leader within Canada, and Canada as a leader in the international community, in the fight against global poverty.

We ask for your support in continuing the levy in the amount of \$2.50 per academic term (\$1.25 per session) for each full-time undergraduate student. This funding will focus in all aspects of EWB-UT, in our projects and outreach to engineering students.

In accordance with the original referendum question, the GSU may request increases to the Canadian Federation of Students (CFS) / Canadian Federation of Students-Ontario (CFS-O) levy by an amount identified by CFS/CFS-O.

Pursuant to approval by a previous referendum, requests for cost of living increases in the CFS/CFS-O portion of the fee are permitted upon approval of a resolution by the Council of the GSU. Pursuant to approval by a previous referendum, requests for increases of less than or equal to industry indexes are permitted in the Supplementary Health Coverage and Dental Plan portions of the fee upon approval of a resolution by the Council of the GSU.

If approved, the total UPS fee will be increased to \$36.00 per session, charged to all full-time University of Toronto at Pharmacy students.

Varsity Publications Inc. (The Varsity)

Background

The Varsity fee has been \$1.25 per session for full-time undergraduate University of Toronto students since fall 2007.

Requests

1) An increase and to continue the Society portion of the fee through the 2009-10 fall/winter academic period.
