Section III: Definitions	
<p>The definition of “Teaching Staff” below is an extract from the <i>Election Guidelines 2011</i>. It is your responsibility to ensure that you are eligible by consulting the <i>Election Guidelines 2011</i>, which provides more details for this definition and the eligibility criteria.</p> <p>“Teaching Staff” means the employees of the University, University College, the Constituent Colleges and the arts and science faculties of the Federated Universities who hold the academic rank of professor, associate professor, assistant professor, full-time lecturer or part-time lecturer, unless such part-time lecturer is registered as a Student, or who hold any other rank created by the Governing Council and designated by it as an academic rank for the purposes of clause 1 (1) (m) of the <i>Act</i>. For the purposes of Governing Council elections, lecturer includes the ranks of Lecturer, Senior Lecturer, Tutor, and Senior Tutor. Lecturer also includes associates in the Faculty of Dentistry. Assistant Professor (conditional), Sessional Lecturer I, Sessional Lecturer II, Sessional Lecturer III, Athletics Instructor, and Senior Athletics Instructor have been designated by the Governing Council as academic ranks for the purposes of clause 1 (1) (m) of the <i>Act</i>.</p>	
Section IV: Departmental Criteria	
<p>For constituencies with more than one elected member on the Academic Board, no more than one person shall be elected from each department or equivalent unit within the particular constituency. As such, teaching staff members from the following departments are <u>ineligible</u> to submit a nomination for this June, 2011 by-election.</p>	
Faculty of Arts and Science	Linguistics; Geography; Philosophy; Classics; Economics; History; Near and Middle Eastern Studies; Ecology and Evolutionary Biology; Computer Science; Germanic Language and Literature; Transitional Year Program; Political Science; and Astronomy and Astrophysics.
Faculty of Medicine	Medical Biophysics; Health Policy, Management, and Evaluation; Physical Therapy; Surgery; Biochemistry; Physiology; Laboratory Medicine and Pathobiology; Otolaryngology; and Paediatrics.
Ontario Institute for Studies in Education	Curriculum, Teaching and Learning and Sociology and Equity Studies in Education.
Section V: Optional Statement	
<p>The nominee may submit a typed biographical statement or other comments, up to a limit of 100 words. The candidate's name will not be counted in the 100-word total if placed at the beginning of the statement. Abbreviations and acronyms will be counted as one word. The nominee's URL will not be counted in the 100 word limit and should be placed at the end of the statement. This statement will be linked to the ballot on the web. If a statement exceeds 100 words in length, only the first 100 words will be printed. It is emphasized that the submission of the biographical statement or other comments is voluntary.</p>
