The College met *in camera* to consider items 3, 4 and 5.

1. Minutes of the Previous Meeting – March 8, 2012

The minutes of the meeting of March 8, 2012 were approved.

2. Business Arising

There was no business arising from the previous meeting.

3. Report of the Chancellor Search Committee

The Vice-Chair gave an overview of the Chancellor Search Committee's Report which was followed by the College's discussion of the Report.

4. Election of the Chancellor

The College held an election for the Chancellor by secret ballot. Once the ballots had been counted, the Chair announced that the Honourable Michael Wilson had been elected as Chancellor of the University of Toronto for a three-year term, effective July 1, 2012 until June 30, 2015.

5. Election of the 2012 - 2013 Executive Committee

At the invitation of the Chair, Ms Sadia Butt, a member of the 2011-2012 Nominating Committee for the Executive Committee (NC-EC), presented the Committee's report.

The College of Electors APPROVED

THAT Mr. Corwin Cambray, Ms Ceta Ramkhalawansingh and Ms Mary Shenstone be appointed to the Executive Committee of the College of Electors for 2012-2013.

The College returned to open session.

The Chair congratulated the newly-elected members of the 2012-2013 Executive Committee and expressed her sincere thanks to Ms Sadia Butt, Ms Tiffany Chow and Mr. Aran Hamilton for their service on the 2011-2012 NC-EC.

6. Selection of the 2012-2013 Nominating Committee for the Executive Committee

The Chair outlined the role of the NC-EC, which was composed of three individuals chosen by election or formed of volunteers from among members in their final year on the College. As the College had just seen, the NC-EC was responsible for recommending the Vice-Chair and three other members of the Executive Committee of the College. The NC-EC normally met once a year following the close of the Executive Committee nomination period to review the applications received and to develop its recommendations to the College. Mr. David Lucatch, Mr. John Richardson and Ms Anne Venton were selected to serve on the 2012-2013 NC-EC.

7. Evaluation of the 2011-2012 Alumni Governor Election Process

The Chair encouraged members to complete the survey on Alumni Governor Recruitment, Selection, and Election Process that had been created and posted online. The results would be reviewed and used to assist the Executive Committee in working to identify ways to improve the College's process in the coming year.

8. Date of Next Meeting

The Chair informed members that the next meeting of the College would be held in the Fall, 2012. The Secretary would notify members of the meeting dates for the year by email later in the summer.

9. Other Business

The Chair reminded members that they were welcome to attend meetings of the Governing Council and its Boards and Committees in order to gain a better understanding of the types of business items considered by central governance bodies. Mr. Charpentier noted that the upcoming meeting of the Governing Council on May 17th would be an informative one for members to attend as the Vice-President and Provost would report on the *Towards 2030: The View from 2012* framework. A member reported on a governance meeting that she had attended.

She had facilitated a number of initiatives designed to strengthen the function of the College and had led both the 2008-09 Chancellor Review/Search Committee and the 2011-12 Chancellor Search Committee. An engraved University of Toronto chair would be given to the Chair as a token of appreciation for her service. The Vice-Chair also thanked the Chair for the great leadership and grace that she had demonstrated over the years. The College applauded the Chair.
