## 1. Senior Appointment

### 2. Chair's Welcoming Remarks

The Chair welcomed new and returning members to the first meeting of the Governing Council for the governance year 2012-13.

The Chair announced that the Lieutenant Governor had issued the order that Mr. Jeff Collins and Ms. Claire Kennedy be appointed to the University of Toronto Governing Council for a period of three years, effective July 18, 2012.

The Chair noted that a speaking request had been received from an individual and that the request was declined as the matter was an admissions issue and as such within the purview of the administration.

# 3. Report of the President

The President welcomed new and returning members. He expressed his gratitude for their important commitment of time to governance and indicated that he looked forward to working together over the next sixteen months.

The President drew governors' attention to an opinion piece in *The Hill Times* that he had authored entitled *Innovation in Canada: Pitfalls and Potential.*<sup>1</sup>

He provided a high-level overview of the current provincial context, with specific focus on the financial stringency facing the province, the consultation process that began over the summer under the leadership of Minister Glen Murray, and the funding challenges for post-secondary institutions. He also spoke to the challenge posed by the institution's substantial pension deficit, as well as the anticipated challenges resulting from provincial directives on compensation.

The President also spoke briefly to the challenges on the federal front, specifically on the research and innovation agenda; to the Boundless campaign and the fact that it was seeing an uptick in its second year; and to the issue of the potential aggregation of asset managers further to the proposal outlined in the 2012 Ontario Budget (John Switzer is chairing an internal group considering this matter).

- It would also be examining and making recommendations regarding the UTM and UTSC Campus Councils and their election processes. A proposal would be distributed broadly.
- The Committee would carefully review all input and report on the progress of its work and general directions at the Governing Council meeting of October 30, 2012.
- Governing Council approval for both specific recommendations and the 2013 Election Guidelines would then be sought at the December 13, 2012 Council meeting.
- (b.) The President acknowledged that this was the new Chancellor's first Governing Council meeting and noted that the previous day Mr. Wilson had attended the opening of the Rotman School of Management expansion, his first university event in his capacity as Chancellor.
