4. The objects for which the corporation is incorporated are:
Objet pour lesquels la personne morale est constituée:

- (a) as successor to the University of Toronto, to manage and operate the University of Toronto Schools in affiliation with the University of Toronto and as part of the University community;
- (b) to provide highest quality and accessible education to students selected on the basis of merit;
- (c) to serve as a resource and facility for the initial and continuing education of teachers;
- (d) to develop, support and advance school and university curriculum, instruction and assessment methods through research and innovation in both the Canadian and international contexts;
- (e) to co-operate, affiliate and contract with schools, post-secondary institutions, educational and professional associations, individuals, community organizations and other organizations and institutions, whether or not incorporated, carrying out objects similar in whole or in part to, or whose activities may assist in enhancing or achieving the fulfillment of, the charitable objects of the Corporation; and
- (f) to do all such other things as are incidental to the attainment of the foregoing objects.

Notwithstanding any other provisions of the Letters Patent incorporating the Corporation, as they may be amended from time to time, the Corporation shall carry on its operations for the benefit of the general public and the activities and operations of the Corporation shall be of a public character and exclusively charitable at law.
