ITEM IDENTIFICATION:

Amendments to the Second Attempt for Credit Policy

JURISDICTIONAL INFORMATION:

Under section 5.6 of its terms of reference, the Academic Affairs Committee is responsible for minor amendments to Campus academic regulations that are consistent with University-wide policy.

GOVERNANCE PATH:

PREVIOUS ACTION TAKEN:

No previous action has been taken.

HIGHLIGHTS:

This proposal outlines changes to the existing Second Attempt for Credit (SAC) sub-policy within the Repeating Passed Courses Policy at the University of Toronto Mississauga (UTM). The purpose of this change is to clarify for students the original intent of this sub-policy and the parameters within it applies.

Under the Repeating Passed Courses Policy, degree and non-degree students are able to repeat any undergraduate course in which they obtained credit for the purposes of satisfying grade requirements for program or course entry or for future graduate studies. The SAC sub-policy further allows students to request up to 1.0 repeated credits to count toward their GPA and their degree credit count in order to qualify for their desired program (subject post). While there is benefit to the Repeating Passed Courses Policy for non-degree students, the SAC sub-policy would

not apply as non-degree students do not enter into programs of study. This proposed policy amendment makes this distinction explicit.

The Office of the Vice-Principal Academic and Dean consulted closely with the Office of the Registrar in the development of this policy amendment. Wide consultation was sought through all three Divisional Undergraduate Curriculum Committees in March 2020 as well as among Department Chairs and unit/program Directors at the April 2020 Chairs & Directors Meeting. The University of Toronto Mississauga Students' Union was also asked to provide feedback. All comments received were incorporated into the current proposal as appropriate.

Additionally, this proposal was sent for information to the Vice-Provost, Academic Programs; the University Registrar; the Deans' Offices; and the Registrars of the Faculty of Arts and Sciences (St. George campus) and the University of Toronto Scarborough.

The proposed amendment will be reflected in the 2020-2021 Academic Calendar, effective September 1, 2020.

FINANCIAL IMPLICATIONS:

There are no net implications for the campus' operating budget.

SECTION 2 - Proposal

1. DESCRIPTION

This proposal outlines changes to the current Second Attempt for Credit (SAC) sub-policy within the Repeating Passed Courses Policy at the University of Toronto Mississauga (UTM). The purpose of this change is to clarify for students the parameters within which this sub-policy applies. The proposed amendments are clearly outlined in calendar copies presented in Section 3 below and will be effective September 1, 2020. .

2. BACKGROUND

In November of 2018, UTM's Academic Affairs Committee (AAC) approved the introduction of a Second Attempt for Credit (SAC) sub-policy within the already existing Repeating Passed Courses Policy, effective May 1, 2019. Before this, students (both degree and non-degree) under the Repeating Passed Courses Policy were able to repeat any undergraduate course in which they already obtained credit for the purposes of satisfying grade requirements for program or course entry or for future graduate studies. The repeated course(s) would be designated as "extra" on the student's transcript and did not contribute to the student's GPA or degree credit count (in the case of degree students). Recognizing that a number of subject posts at UTM require not just a minimum grade in a specific course for program entry, but also a minimum GPA that includes a specified course(s), the SAC sub-policy was introduced in May 2019. SAC allows students to request up to 1.0 repeated credits to count toward their GPA and their degree credit count. For such courses, the original grade and credit earned would be marked as "extra" on the transcript.

3. RATIONALE

The intent of the SAC sub-policy is specifically to enable current undergraduate students to qualify for their desired program (subject post). Some UTM programs require a minimum grade in a specific course and/ or a minimum GPA score earned within a specified set of courses for program entry. For students who did not achieve this minimum grade the first time they completed the course, this would mean they could never qualify for the program regardless of their other academic successes. With the SAC subpolicy, students can now not only repeat the course to earn the minimum grade but can also request to have the course count toward their GPA, allowing them to potentially qualify for their program of choice. Additionally, it was demonstrated that the restriction of using the SAC sub-policy on 1.0 credits did not have a significant impact on a 20.0 credit CGPA, and therefore protected the integrity of an undergraduate degree. Given the intent of the SAC sub-policy, it should only apply to current degree students at UTM (as non-degree students are not permitted to enter in programs/ subject posts). The Repeating Passed Courses Policy, under which the SAC sub-policy sits, can apply to degree and nondegree students as its purpose is to allow students to repeat courses for grade improvement to both qualify for course and program entry as well as future graduate studies. For this reason, an amendment to the SAC sub-policy is being proposed to reflect a stronger alignment to its intended purpose and increased clarification of the students to whom this sub-policy applies. The parent Repeating Passed Courses Policy remains unchanged, applying to both degree and non-degree students.

4. CONSULTATION

The Office of the Vice-Principal Academic and Dean consulted closely with the Office of the Registrar in the development of this policy amendment. Wide consultation was sought through all three Divisional Undergraduate Curriculum Committees in March 2020 as well as among Department Chairs and unit/program Directors at the April 2020 Chairs & Directors Meeting.
