Sections 5.2.1 and 5.2.2 provide that compulsory non-academic incidental fees for representative student committees and divisional student societies "are approved by the Board."

**RECOMMENDATION:**

**BE IT RESOLVED**

THAT beginning in the Fall 2019 session, the **Arts and Science Students' Union** fee be increased as follows:

- (a) an increase of \$1.50 per fall and winter sessions in the Society portion of the fee.

THAT beginning in the Fall 2019 session, the **Association of Part-time Undergraduate Students** fee be increased as follows:

- (a) an increase of \$0.08 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee;
- (b) an increase of \$6.56 per fall and winter sessions in the Accident & Prescription Drug Insurance Plan portion of the fee; and
- (c) an increase of \$5.48 per fall and winter sessions in the Dental Plan portion of the fee.

THAT beginning in the Fall 2019 session, the **Engineering Society** fee be increased as follows:

- (a) an increase of \$0.56 per fall and winter sessions in the Society portion of the fee (\$0.53 part-time);
- (b) the continuation of, and an increase of \$0.03 per fall and winter sessions in, the U of T Aerospace Team portion of the fee through 2020-21 (full-time only);
- (c) the establishment of \$1.00 per fall and winter sessions in the Baja SAE Design Team portion of the fee for full-time students through 2020-21 (full-time only);
- (d) the continuation of, and an increase of \$0.45 per fall and winter sessions in, the Blue Sky Solar Racing Team portion of the fee through 2020-21 (full-time only);
- (e) the continuation of, and an increase of \$0.12 per fall and winter sessions in, the Concrete Canoe Team portion of the fee through 2020-21 (full-time only);
- (f) the continuation of, and an increase of \$0.25 per fall and winter sessions in, the Concrete Toboggan Team portion of the fee through 2020-21 (full-time only);

- (g) the establishment of \$0.75 per fall and winter sessions in the Engineers in Action portion of the fee for full-time students through 2020-21 (full-time only);
- (h) the continuation of the Engineers Without Borders portion of the fee through 2020-21 (full-time only);
- (i) the continuation of the Formula SAE Racing Team portion of the fee through 2020-21 (full-time only);
- (j) the continuation of, and an increase of \$0.25 per fall and winter sessions in, the Human-Powered Vehicle Design Team portion of the fee through 2020-21 (full-time only);
- (k) the continuation of the U of T Robotics Association portion of the fee through 2020-21 (full-time only); and
- (l) the continuation of, and an increase of \$0.25 per fall and winter sessions in, the Robotics for Space Exploration portion of the fee through 2020-21 (full-time only).

THAT beginning in the Fall 2019 session, the **Innis College Student Society** fee be increased as follows:

- (a) the establishment of \$5.00 per fall and winter sessions in the New Building Fee portion of the fee for full-time and part-time students.

THAT beginning in the Fall 2019 session, the **New College Student Council** fee be increased as follows:

- (a) the establishment of \$4.50 per fall and winter sessions in the Wilson Lounge Renovation Levy portion of the fee for full-time students (\$2.00 part-time).

THAT beginning in the Fall 2019 session, the **University College Literary & Athletic Society** fee be increased as follows:

- (a) an increase of \$0.22 per fall and winter sessions in the Society portion of the fee (\$0.08 part-time).

THAT beginning in the Fall 2019 session, the **University of Toronto Graduate Students' Union** fee be increased as follows:

- (a) an increase of \$0.01 per sessions in the Bikechain portion of the fee for full-time students;
- (b) an increase of \$0.19 per sessions in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee (\$0.09 part-time);
- (c) an increase of \$0.06 per fall and winter sessions in the Ontario Public Interest Research Group portion of the fee (\$0.03 per fall session and \$0.04 per winter session part-time);
- (d) an increase of \$0.01 per sessions in the Sexual Education Centre portion of the fee (\$0.01 per fall session part-time);
- (e) an increase of \$2.50 per fall and winter sessions in the Supplementary Health Coverage portion of the fee; and
- (f) an increase of \$2.50 per fall and winter sessions in the Dental Plan portion of the fee.

THAT beginning in the Fall 2019 session, the **University of Toronto Students' Union** (legally, the Students' Administrative Council) fees be increased as follows:

- (a) an increase of \$0.44 per session in the Society portion of the fee;
- (b) an increase of \$0.01 per session in the Bikechain portion of the fee;
- (c) an increase of \$0.16 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee;
- (d) an increase of \$0.07 per session in the Downtown Legal Services portion of the fee for students on the St. George campus;
- (e) an increase of \$0.02 per session in the Downtown Legal Services portion of the fee for students on the UTM campus;
- (f) an increase of \$0.02 per session in the Student Refugee Program portion of the fee;
- (g) the continuation of the U of T Aerospace Team portion of the fee through 2020-21;
- (h) an increase of \$9.28 per fall and winter sessions in the Accident & Prescription Drug Plan portion of the fee;
- (i) an increase of \$7.76 per fall and winter sessions in the Dental Plan portion of the fee;
- (j) for students on the St. George campus only, an increase of up to \$4.01 per session in the Student Commons Capital Levy portion of the fee; and
- (k) for students on the St. George campus only, the establishment of \$6.50 per session in the Student Commons Operating Levy portion of the fee.

THAT beginning in the Fall 2019 session, the **Varsity Publications** society fee be increased as follows:

- (a) an increase of \$0.02 per session in the society portion of the fee (graduate); and
- (b) an increase of \$0.06 per session in the society portion of the fee (undergraduate).

The Office of the Vice-Provost, Students (OVPS) has received a number of fee change requests from student societies. The applications have been reviewed in light of the requirements of the *Policy for Compulsory Non-Academic Incidental Fees*, are found to be in compliance with these requirements, and are recommended for approval.

Requests for fee increases from student societies must meet a number of requirements. Section B.4. of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the University's general expectations:

*Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization. The procedures to request approval of a new fee or an increase to an existing fee shall be published in the Handbook for Student Societies.*

#### *Cost-of-Living Increases*

- (a) *Where the amount of an increase in the fee charged is not greater than the year-over-year change in consumer prices for Ontario as measured by Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. In special circumstances (e.g., when a portion of a student society fee is designated for a health plan or capital project), other inflation indexes or predetermined inflation factors may be used, provided that the request is supported by the results of a previous referendum approving the use of the specific inflation index or predetermined inflation factor.*

#### *Referendum Requirement*

- (b) *Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.*

The procedures for handling fee change requests (from the *Handbook for Student Societies* published by the OVPS) also provide that requests for a fee increase must be supplied with the following:

*Evidence that the request to change the existing fee (or to institute a new charge) has been authorized by due constitutional process of the organization. This evidence should include a copy of or specific reference to the section of the society's constitution which related to the mechanism for fee changes, minutes of the meeting at which the resolution to request the change was passed, details and results of any referenda related to the subject which may have been held within the division, and publicity given the matter to ensure that those who may be affected by the change are aware of the proposal, including size and purpose of the increase, and have had the opportunity to make their views known.*

Normally, the administration intersects with these processes at two points. Initially, student societies may seek advice from the OVPS on the wording of the referendum questions (with respect to clarity and technical language). The second point occurs after the referendum when the student society makes the formal request for a fee increase. The recommendation for approval is derived from the assessment of whether or not the society has met the requirements established in the *Policy* and relevant procedures.

Occasionally, the OVPS is asked to look into complaints about referendum procedures and compliance with relevant portions of the society's constitution and/or by-laws. The results of these investigations play a significant role in the assessment of the request and the recommendation for approval.

The assessment of requests for fee increases is normally based upon the following expectations:

1. The student society must make the request in a manner consistent with the *Policy for Compulsory Non-Academic Incidental Fees* and the University's procedures for increases to student society fees;
2. When required, there must be a positive result in a referendum for a fee increase (special conditions established by the society's by-laws, such as quorum, must also be met);
3. The referendum question itself should be clear and provide enough information to students in order to gain a full understanding of the implications of the question and proposed fee for them;
4. The referendum must be held in a fair manner, advertised and promoted in a reasonable manner, and the members of each organization should be given a reasonable opportunity to vote; and
5. Each organization must comply with the provisions of its own by-laws, rules of procedure, and specific policies and procedures approved by the society's board or council.

Societies which have previously received approval (by referendum) from their members for an annual cost-of-living increase in the society's portion of the fee may request increases, upon approval by the society's board or council, of up to the previous Ontario December-over-December cost-of-living increase (consumer price index) calculated by Statistics Canada. The December 2018 consumer price index for Ontario was 2.3%.

As outlined in the excerpt from the *Policy* above, where members of a society have given consent (through a previous referendum) to the concept of inflationary increases according to a specific inflation factor or measure, this inflation factor may be used. For example, the Association of Part-Time Undergraduate Students (APUS), the University of Toronto Graduate Students' Union (UTGSU), and the University of Toronto Students' Union (UTSU) may request increases in the designated portions of their fees for health and dental plans at a rate established by approval of a previous referendum. APUS and the UTSU may request increases in their health and dental plan fees of up to 10%. The UTGSU may request increases in its health and dental plan fees of an amount less than or equal to a health industry index.

It is important to note that when dealing with a student society request for a fee change, it is the society's own constitution, by-laws, or established policies that set the standards for acceptable results in referenda. In some cases, society constitutions establish a minimum voter turnout in order to consider a referendum result to be valid. The University has not established additional criteria with respect to valid referendum voter turnout.

In addition, with respect to both requests for increases based upon the results of a referendum, and increases which require only the approval of the society's board or council, the administration relies on the assurances of student societies that due constitutional processes and fair procedures have been followed.

# Arts and Science Students' Union (ASSU)

---

## Background

In 2018-19, the ASSU fee was \$9.50 per fall and winter sessions, charged to all full-time undergraduate Faculty of Arts & Science students.

## Requests

1. An increase in the society portion of the fee.

A referendum was held from February 13, 2019 to February 14, 2019, in which full-time undergraduate Faculty of Arts & Science students were asked to support an increase to the society portion of ASSU fee. The wording of the question was as follows:

### **ASSU Student Society Fee (Part A)**

*The Arts & Science Students' Union (ASSU) is the largest academic student union in Canada. Despite this, ASSU currently has one of the lowest student society fees at the University of Toronto – currently collecting \$9.50 per full-time A&S student per term (fall, winter, and summer). ASSU funds (over \$180,000) to 62 Student Course Unions in departments and programs; grants over \$36,000 in bursaries and awards; funds over \$21,000 in grant money for undergraduate research and travel to academic conferences. ASSU also produces and organizes several events, programs, and academic reforms around campus.*

*ASSU provides a multitude of services for students ranging from faxing, to selling test packages to printing services. ASSU works with the Dean's Office on academic concerns, ensuring that Faculty rules, regulations and policies are fair and in line with what students want. ASSU also regularly supports students - advising students on their personal academic grievances and fighting for their rights both inside and outside the classroom. In fact this is how a referendum seeking to extend Fall Reading Week into an entire week was attained. ASSU has brought speakers such Ta-Nehisi Coates to UofT, and organized coffee houses and EXAM JAM as de-stressers for students. Additionally, ASSU continues to run its Project: Universal Minds—a free tutoring program that matches volunteer UofT tutors with local high school students, its Undergraduate Research Conference – where A&S students present their research to the UofT Community and started a new Mentorship Program for A&S students this year.*

*ASSU, your academic Student Union is requesting a \$1.50 increase per term (fall, winter, and summer) to the ASSU fee so that we can expand on our existing projects, increase bursaries/scholarships, and funding the growth of our Course Unions and their work. We want to continue to ensure that students are able to excel academically and have access to equitable opportunities towards success.*

*Do you approve a \$1.50 increase, from \$9.50 to \$11.00 per term (fall, winter, and summer), in the ASSU society fee on full-time Arts & Science undergraduate students on the St. George campus, commencing in the Fall 2019?*

## Association of Part-time Undergraduate Students (APUS)

In 2018-19, the APUS fee was \$138.56 per fall and winter sessions, charged to all part-time undergraduate students on all campuses. The fee included:

- \$4.02 per session for the Canadian Federation of Students (CFS)/CFS-Ontario;
- \$65.63 (including an administration fee and sales tax) per fall and winter sessions for an Accident & Prescription Drug Insurance Plan; and
- \$54.76 (including an administration fee and sales tax) per fall and winter sessions for a Dental Plan.

### Requests

1. A cost-of-living increase in the Canadian Federation of Students (CFS) & CFS-Ontario portion of the fee.

At its meeting held on March 8, 2019, the APUS Board of Directors approved a resolution to request a cost-of-living increase to the Canadian Federation of Students (CFS) & CFS-Ontario portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

2. An inflationary increase in the Accident & Prescription Drug Insurance portion of the fee.

At its meeting held on March 8, 2019, the APUS Board of Directors approved a resolution to request an inflationary increase to the Accident & Prescription Drug Insurance Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

3. An inflationary increase in the Dental Plan portion of the fee.

At its meeting held on March 8, 2019, the APUS Board of Directors approved a resolution to request an inflationary increase to the Dental Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

## Engineering Society (EngSoc)

### Background

In 2018-19, the EngSoc fee was \$96.32 per fall and winter sessions, charged to all full-time undergraduate Faculty of Applied Science and Engineering students (\$49.06 for part-time students and Professional Experience Year [PEY] students). The fee included:

- \$25.60 per fall and winter sessions for the society portion of the fee (\$24.06 part-time);
- \$3.32 per fall and winter sessions for the U of T Aerospace Team portion of the fee (full-time only);
- \$2.75 per fall and winter sessions for the Blue Sky Solar Racing portion of the fee (full-time only);
- \$1.25 per fall and winter sessions for the Concrete Canoe Team portion of the fee (full-time only);
- \$1.50 per fall and winter sessions for the Concrete Toboggan Team portion of the fee (full-time only);
- \$1.50 per fall and winter sessions for the Engineers Without Borders portion of the fee (full-time only);
- \$2.75 per fall and winter sessions for the Formula SAE Racing Team portion of the fee (full-time only);
- \$2.00 per fall and winter sessions for the Human-Powered Vehicle Design Team portion of the fee (full-time only);
- \$2.00 per fall and winter sessions for the U of T Robotics Association portion of the fee (full-time only);
- \$1.75 per fall and winter sessions for the Robotics for Space Exploration portion of the fee (full-time only)

### Requests

1. A cost-of-living increase in the society portion of the fee.

At its meeting held on March 17, 2019, the EngSoc Board of Directors approved a resolution to seek a cost-of-living increase in the society portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

2. The continuation and increase of the U of T Aerospace Team portion of the fee.

A referendum was held from March 27, 2019 to March 29, 2019, in which undergraduate Faculty of Applied Science and Engineering students were asked to support the continuation and increase of the dedicated U of T Aerospace Team portion of the EngSoc fee. The wording of the question was as follows:

*Do you support a \$3.35 per semester per student levy for the University of Toronto Aerospace Team for the 2019-2020 and 2020-2021 terms? (\$3.35 per semester per student for both Fall and Winter semesters, for a total of \$6.70 annually).*

Central to the plans are a larger commuter lounge; expanded spaces for Innis student government, student clubs, and the Innis Herald; an extensive network of new study and lounge spaces; and a reconceived student resource hub that will combine the functions of the current library, writing centre, and related student services. This is an exciting project that will give all students at Innis the spaces that they deserve.*

*The Innis College Student Society (ICSS) is seeking consent from its members for the creation of a special project levy. Beginning in Fall 2019, Innis College students shall contribute \$5 per session for 5 years or until the opening of the new wing, whichever occurs first. Upon opening of the new wing, for a period of 20 years, Innis College students shall contribute \$15 per session. This levy shall only be collected in the fall and winter sessions.*

*Funds collected as part of this levy will contribute solely to the cost of building student co-curricular spaces, such as the expanded café, commuter lounge, student activity space, and offices for student organizations and clubs, including the ICSS and Herald.*

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

9. An increase in the Student Commons Capital Levy portion of the fee (St. George only).  
At its meeting held on April 4, 2019, the UTSU Board of Directors approved a resolution to request an increase to the Student Commons Capital Levy portion of the fee.

The UTSU Board has requested the increase in accordance with the terms of the original 2007 Student Commons referendum.

In the event that the UTSU does not occupy the Student Commons by Fall 2019, the UTSU Board of Directors approved a resolution to request an inflationary increase to the Student Commons Capital Levy portion of the fee in the amount of \$1.02 per session.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

10. The establishment of a Student Commons Operating Levy portion of the fee (St. George only).

At its meeting held on April 4, 2019, the UTSU Board of Directors approved a resolution to request to establish a Student Commons Operating Levy portion of the fee.

The UTSU Board has requested the establishment of the fee in accordance with the terms of the original 2007 Student Commons referendum.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

- (c) an increase of \$0.16 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee;

- (e) an increase of \$0.02 per session in the Downtown Legal Services portion of the fee for students on the UTM campus;
- (f) an increase of \$0.02 per session in the Student Refugee Program portion of the fee;

- (g) the continuation of the U of T Aerospace Team portion of the fee through 2020-21;
- (h) an increase of \$9.28 per fall and winter sessions in the Accident & Prescription Drug Plan portion of the fee;
- (i) an increase of \$7.76 per fall and winter sessions in the Dental Plan portion of the fee;
- (j) for students on the St. George campus only, an increase of up to \$4.01 per session in the Student Commons Capital Levy portion of the fee; and
- (k) for students on the St. George campus only, the establishment of \$6.50 per session in the Student Commons Operating Levy portion of the fee.

If approved, the total UTSU (St. George) fee will be up to \$250.54 per fall and winter sessions, charged to all full-time undergraduate students on the St. George campus; and the total UTSU (UTM) fee will be \$222.54 per fall and winter sessions, charged to all full-time undergraduate students on the University of Toronto Mississauga campus.
