**The Meeting was held in Closed Session.****1. Review of Academic Programs and Units Follow-up Reports from Previous Reviews**

The Committee received a summary report by Professor Ernest Lam, Chair of the Committee on Academic Policy and Programs (AP&P) regarding two follow-up reports from previous academic programs and unit reviews that had been considered by AP&P at its meeting on November 1, 2018. The following reports were received:

- b. Department of Chemical and Physical Sciences and its Programs (University of Toronto Mississauga)

**Professor Lam confirmed that the Committee was satisfied with the follow-up reports and determined that there were no specific issues of concern to be brought forward to the Academic Board.**

**2. Semi-Annual Report on the Reviews of Academic Units and Programs, April- September 2018**

Professor Lam reported on the 14 decanal reports received by the Committee on Academic Policy and Programs (AP&P) at its meeting on November 1, 2018. He noted that the reviews had been conducted appropriately and within the policies; he also thanked the Chairs of the four reading groups, Professors Amara, Feng, Kim and Nikiema, for thorough and thoughtful work in asking questions and framing the reviews for the Committee.

Professor Lam indicated that seven follow-up reviews had been requested.
